


# Index of turnover in industry

2014, November

## Turnover in manufacturing contracted by nearly 2 per cent in September to November from the year before

According to Statistics Finland, turnover in manufacturing in the September to November period was 1.7 per cent lower than in the corresponding period of the year before. Domestic sales contracted by 2.2 per cent and export turnover by 1.3 per cent from one year ago.


### Three months' year-on-year change in turnover in manufacturing (C) sub-industries (TOL 2008)

Nearly all **sub-industries of manufacturing (C)** contracted from the corresponding period of the year before. Turnover contracted most in the chemical industry, by 6.4 per cent, in the textile, clothing and leather industry, by 6.3 per cent, and in the electrical and electronics industry, by 5.7 per cent. Turnover in the metal industry remained on level with the previous year.

In the **main categories of other industries**, water supply, sewerage, waste management and remediation activities grew by 0.4 per cent. Turnover of electricity, gas, steam and air conditioning supply contracted by 1.6 per cent and turnover of mining and quarrying by 4.6 per cent from one year ago.

The index of turnover in industry describes enterprises whose main industry is manufacturing. The calculation of the indices is based on the Tax Administration's value added tax data which are supplemented with data obtained with Statistics Finland's sales inquiry. The monthly turnovers of manufacturing enterprises can vary considerably, especially in the metal industries. The variation is mainly due to invoicing practices. The final invoice for major machinery deliveries and projects may be recorded in the sales of one month, even if the delivery had required the work of several months or years.





**Appendix figure 1. Trend series on total turnover, domestic turnover and export turnover in manufacturing**





**Appendix figure 2. Trend series on total turnover, domestic turnover and export turnover in the forest industry**




